Training Sessions

MARAC AWARENESS - Multi Agency Risk Assessment Conference, 50 minutes;

This awareness session is for anyone wishing to learn more about MARAC and its processes. There will be information on the background of MARAC and its being part of public protections services in Ayrshire and Arran.

MARAC INFORMATION/DASHric Training; Domestic Abuse Stalking and Honour Based- Violence Risk Indicator Checklist; 2 and ½ hours

This training session is aimed at those front line staff who may find themselves in a position of assessing high risk through domestic abuse with an individual. There will be information on the background of MARAC and discussions around recognising individuals at high risk and making a referral to MARAC

The DASH is an assessment tool to inform referral to a MARAC. There will be an opportunity to use the DASH-ric using a case study as well as discussion around the assessment tool. Attendees will be sent some pre training reading along with the MST invite prior to the training session

MARAC Agency Representatives Training, 3 hours;

This workshop is suitable for those who are new to the role of MARAC agency representative, covering MARAC, DASH-ric and the responsibilities of an effective MARAC rep. The workshop aims to improve understanding of a multi-agency response to domestic abuse, the evaluated MARAC model, MARAC processes locally and the role of the MARAC Representative within this such as assessment of high risk, the referral criteria and the referral process for MARAC and formulating an action plan which focuses on risks and safe guarding victims. There will be discussion on the 10 principles for an effective MARAC and the benefits of implementing MARAC locally as well as highlighting the legislation

which supports the lawful sharing of information. Some pre session reading will be sent out along with the MST link prior to the session.
